- _____ **Annual Fellows Gala:** Coordinates nominations for the Distinguished Honoree and Calogero Justice awards as well as all planning and implementation aspects of the gala including venue, sponsorships, auction, menu and logistics.
- _____ **Development:** Works with Board and Development Department to provide funding for the annual operations budget, major gifts, special projects and endowment; recommend policies governing development activities to the Board; and identify and cultivate relationships with foundations, corporations, individuals and other potential supporters.
- _____ **Editorial:** Works with Communication Department and the LBF Secretary on message creation on all external communication including talking points, marketing and education material, web site, annual report and bar publications.
- _____ **Education:** Promotes study and research in the field of law and the continuing education of lawyers. Oversight of the Oral Histories Project, Scholar-in-Residence Program (publication and distribution of literary works on legal subjects) and the Legal Archives.
- _____ **Grants:** Chaired by the Treasurer, reviews applications and makes recommendations to the Board with respect to the disbursement of grant funds; studies and recommends policies regarding standards by which applications are to be measured and funding decisions are to be made.
- _____ **IOLTA Administration:** Oversight of attorney participation in the IOLTA program; recommends policy regarding the identification of and pursuit of accounts which have not been enrolled in IOLTA; oversight of bank participation in the IOLTA program by working to maximize program income and monitor changes in the banking industry; and recommends policies regarding participating banks.
- _____ **Judicial Liaison:** Serves as liaison between bench and bar to support and enhance professionalism and civility; oversight of the Distinguished Lecture Series, the Law Signature Courtroom project, which creates a courtroom environment for students to foster interest in the legal profession, and other bench/bar activities identified by the committee.
- _____ **Kids' Chance:** Oversight of the Kid's Chance Program which awards educational scholarships to the dependents of workers who have been killed or permanently and totally injured in a work related accident.
